In April this year ten clergymen in Sydney signed a Declaration on World Peace. It read:

To-day, on every mind and every heart in Australia there weighs some of the burden of war.

War is a denial of everything for which we live-of our beliefs and of every creative urge. On all sides there is a yearning for the peace which can permit the flowering of all that is best.

We representative citizens and ministers of religion view with the greatest alarm the gathering threat of world war. Yet we are not without hope.

We refuse to believe that another world war is inevitable. With all our hearts we feel that, with all men of goodwill united, peace can be saved.

There are no differences between States that should not be settled by patient negotiation. Negotiation must replace war as the method of settling differences between nations.

Let all men and women speak out for peace. There must be no isolation in this urgent task. Our lives, the lives of our children, the lives of all peoples, are at stake. Let all hands and hearts meet in this great enterprise of peacemaking.

We suggest that a broad, representative section of the people in every city, town and country centre, meet and discuss ways and means of winning the peace and saving humanity. Peace can not wait-it must be won.
