The victory of the bourgeoisie is the victory of a profoundly historical time, because it is the time corresponding to an economic production that continuously transforms society from top to bottom. History, which until then had seemed to involve only the actions of individual members of the ruling class, and which had thus been recorded as a mere chronology of events, is now understood as a general movement - a relentless movement that crushes any individuals in its path. By discovering its basis in political economy, history becomes aware of what had previously been unconscious; but this basis remains unconscious because it cannot be brought to light. This blind prehistory, this new fate that no one controls, is the only thing that the commodity economy has democratized.

A Nation Dominated By Work
Thirty years ago, the average Australian worker spent less
than forty hours a week at work – the vast majority of this
time was in steady employment, working on weekdays
between the hours of 8m and 6pm. This pattern of
working life was shared across the broad community,
providing opportunity for most Australians to enjoy
consistent patterns of life outside work – to spend time on
a predictable basis with family and friends, and in other
community-related pursuits.

The past three decades have been a time of unambiguous conomic prosperity for our country. But this success has come at a price. Working patterns have altered to such an extent that Australia is now the only high-income country in the world that combines:

- average working hours that are at the top end amongst high-income nations
- a strong tendency for work on weeknights and weekends, and
- a relatively large proportion of the working population employed on a casual basis.

#### The Harsh Reality: Relational Breakdown and Dysfunction

A significant body of evidence suggests that those people who work long and unsocial hours spend less quality time with their families and firends and that most Australian families are suffering time pressure resulting from their

An emerging body of international research shows that these long and atypical working patterns are associated with dysfunctional family environments, including:

a) Negative health outcomes for those working these times, particularly if they are parents
 b) Strained family relationships

c) Parenting marked by anger, inconsistency and ineffectiveness And, critically, both long/atypical hours and dysfunctional family environments are associated


d) Reduced child wellbeing.

Notably, these associations are evident when either or bathers' not just mothers' work matters to children. And although low-income members of Australian society are generally more keenly affected by these changes, the impact is shared across all strata in our community.

Unsurprisingly, over the last 30 years in Australia, the decline in family relational health has led to an increased incidence of separation and divorce. And there are now more single parents than ever before. With only a single parent providing care for one or more children, increased time pressure and stress increase the probability of adult ill health, and parenting and child difficulties.

Other trends in the Australian workplace, and society more broadly, exacerbate the relational health problems described here and leave the workforce increasingly vulnerable to an eventual downtum in the economy. These trends include a sustained reduction in job stability, intensification of work responsibilities and increased household debt.



All documents recording any payments, donations or financial assistance, howsoever described, received by Union Solidarity, or any member, sponsor, volunteer, or other person(s) affiliated with Union Solidarity, which was made by, or on behalf of any employee, associate to or representative of the AMWU. A contravention, without reasonable excuse, of the requirement to produce the documents identified in this notice is an offence under section 819 of the Act. While in INDONESIA - Manpower and Transmigration minister Erman Suparno called on the country's workers to peacefully celebrate World Labor Day, which falls on May 1. "Everybody can celebrate, either by holding a thanksgiving ceremony or by having music concerts, but don't make any anarchistic actions," The minister said he hoped the celebrations would not disrupt the people's daily activities. "Don't let the event become a spook to the people, terrifying them and preventing them from doing their daily activities with typical demonstrations and anarchistic action...J.akarta police chief Adang Firman told reporters after monitoring the capital from a sell their time and energy for 12 hours of helicopter that 10,000 security personnel had been deployed to control the rallies and another 50,000 were on standby.

All May Day rallies were banned in Surabaya, the country's second largest city, because the workers' holiday coincided with a religious holiday, police said. about youth wages

Many hosses try to justify paying young people poverty wages. Below are some of the myths they use backed up by some real facts about the situation.

Boss's myth: Young people need more supervision and training than older workers. That's why you get paid less. Worker's fact: Many young workers have had previous work experience. Some have even worked as supervisors or managers. While all workers need some initial on the job training it is rubbish that young people are harder to train than adults. Often they are much easier to train.

If young people needed more training than older workers why is it that bosses often write young workers off the roster once they have turned 18 or reach the full adult age? This is only because it costs them more. They are not interested in having workers with experience only workers with small pay packets. The practice of writing people off the roster is of course illegal, and it's discrimination on the basis of age. An employer cannot sack you for being too old. But unfortunately they lie a lot.

Boss's myth: Young workers don't deserve the adult wage. Workers fact: The fact is employers expect young people to perform the same duties and work just as hard as everybody else so it's only fair for young workers to expect the employers to pay them a decent wage. The concept of equal pay for equal work should apply to all.

Boss's myth: Young people are lazy.

Worker's fact: Across the country 16 and 17 year olds are employed as supervisors and duty managers. Often they have to supervise people twice their age. The pace of work in fast food and retail is also much faster than in industries

Workers fact: Most young people do support themselves in some form and often contribute to their household income. Young workers don't get half price rent, food or petrol. If we get charged full price for the cost of living it is only fair that we get full pay. Because of youth wages many young people are forced to live in poverty even though they have jobs.

Boss's myth: Abolishing youth rates would increase youth unemployment

Workers fact: The argument that employers will be less likely to employ young people if they have to pay them more is rubbish. There is absolutely no evidence to support this. When unemployment is at such low levels and with a chronic skills shortage where are they going to find these people to fill the jobs? Also most fast food and retail outlets want to attract young customers that is why they employ young

Fight to abolish youth rates - Youth rates hurt all workers because the lowest wage in a labour market determines all other wages. This means that adults are more likely to be forced into accepting lower wages if they know that the boss could employ a young worker for less. Low adult wages mean more young people working on low youth wages to support their families. The long-term end result is lower wages for all workers. For students and young workers this means working extremely long hours just to make ends meet.

Age discrimination is just like all other forms of discrimination including sexism and racism. If we stick together we win. A win for young workers, is a win for all

All power to the South African Dockers. Everybody knew just what sort of "defence" the Chinese weapons would used to inflict upon the population if they ever reached Zimbabwe. All the politicians ummed and ahhed and generally wrung their hands. Thabo Mbeki told journalists that South Africa would not, could not, possibly, interfere in a legitimate transaction between Zim-babwe and China.

The 300,000-strong South African Transport and Allied Workers Union (Satawu) said it would be "grossly irresponsible" to touch the cargo of ammunition, grenades and mortar rounds on board the Chinese ship An Yue Jiang anchored outside the port.

So in the end it was up to the workers.

A Satawu spokesman Randall Howard said: "Our members employed at Durban container terminal will not unload this cargo, neither will any of our members in the truck-driving sector move this cargo by road. South Africa cannot be seen to be facilitating the flow of weapons into Zimbabwe at a time where there is a political dispute and a volatile situation between Zanu-PF and the MDC."

The London-based International Transport Workers' Federation (ITF) and the Congress of South African Trade Unions (Cosatu) said vesterday they were mobilising unions in China and Africa, including those in Angola, to take a firm stand and to stop the ship from offloading its cargo of weapons. The ITF, which consists of more than 650 unions, representing 4,5-million workers in 148 countries, is believed to have been instrumental in Mozambique's refusal allow the ship to dock in Maputo after ITF affiliate the South African Transport and Allied Workers Union (Satawu) asked it to intervene.

It is some sixty after the revolution in China that brought

the Communist Party to power theoretically in the interests of the workers and poor peasants; nearly thirty years after Mugabe came to power in Zimbabwe and solidified his regime with the help of troops from the fifty year old "revolutionary" Cuba; fourteen years since multi-racial elections were first held in South Africa. Still with all this political change and revolution the workers remain where they have always been. We are on the bottom still forced to use direct action to protect the basic human rights of our colleagues. IT is where we always were and where we always will be. A change of politicians is the joy of fools. We can develop our economic power and solidarity on the job, however, by following (for example) the excellent example of the Durban dock workers and making an injury to one an injury to all.(It's on the Satawu badge) If we do that then we could push through some real change. At least in South Africa workers have shown that they are not passive victims of a neo-liberal spectacular commodity economy sitting on their fundamentals at the end of history. (Read: A flock of bloody sheep.)

And now AUSTRALIA has supported calls for a global ban on arms sales to Zimbabwe. Foreign Monster Stephen Smith is appalled. "The continued delay demonstrates the Mugabe government's utter contempt for democratic principles and processes," Mr Smith whimpered. "I strongly support international efforts that prevent the Mugabe regime from being further equipped to commit further human rights violations against the already long suffering Zimbabwe people."

Which is interesting because under current law and "Labor" Party policy if Australian workers took the same actions as the South African dock workers it would be illegal. Zimbabwe is not the only place on the planet that needs an extension of human rights. To bring us up to the level of certain parts of Africa.

The basic fact is that wages don't drive inflation At best, workers try to keep up with inflation by attempting to get wage rises after the prices of other commodities like food, housing, health and transport rise due to excessive money printing by the Treasury. At worst, inflation is a way to cut wages for the working class. The historical proof is in the \*real\* capitalist pudding. While nominal wages have increased, \*real wages\* adjusted for inflation have staved relatively stable. For example, in Australia from 1982-1996 real average weekly ordinary time earnings in 1996 dollars rose from \$667 in 1982 to \$698 in 1985 and fell to \$656 in 1990 while rising again to \$706 in 1996. In the USA, the same pattern occurs. As measured in 1982 U.S. dollars workers were making \$302 a week in 1962 and \$277 in 2004.

On the other hand, output per worker or productivity in both countries increased exponentially over the same time period. The \*average\* increase in productivity of workers in Australia has been 1.7% per year. This figure is not subject to inflation, thus every decade workers real productivity of goods and services increases by at least 17%. However, real wages have been kept relatively stable in Australia and in the U.S.A. they have actually decreased from \$302.52 to \$277.57 per week. Thus, increasing productivity, which means using less labour-time to produce the same value/commodity, without even increasing the real wages of workers has actually led to a generalised lowering of the value and price commodities and an increase the rate of profit for the employing class. At the same time, inflation of the money supply has taken place.

Inflation has led many in the public to think that workers are making too much money as wages which haven't been adjusted for inflation have increased over the years in Australia e.g. 40% from 1982-1996. The reality of real wages tells quite a different story. Even if real wages increase, the fact of ever increasing productivity show will show up in the economy as a lowering of value and if supply and demand remain equal, a

To sum up: real wages amount to a fraction of the total wealth which the working class is creating and increasing productivity of the working class actually contributes tolowering the price of the commodities it produces. The cause of inflation is the government's printing of more paper money and debt than the workers can cover in producing new values

#### Preamble to the IWW Constitution

The working class and the employing class have nothing in common. There can be no peace so long as hunger and want are found among millions of the working people and the few, who make up the employing class, have all the good things of life.

Between these two classes a struggle must go on until the workers of the world organise as a class, take possession of the means of production, abolish the wage system, and live in harmony with the Earth.

We find that the centring of the management of industries into fewer and fewer hands makes the trade unions unable to cope with the ever growing power of the employing class. The trade unions foster a state of affairs which allows one set of workers to be pitted against another set of workers in the same industry, thereby helping defeat one another in wage wars. Moreover, the trade unions aid the employing class to mislead the workers into the belief that the working class have interests in common with their employers.

These conditions can be changed and the interest of the working class upheld only by an organisation formed in such a way that all its members in any one industry, or in all industries if necessary, cease work whenever a strike or lockout is on in any department thereof, thus making an injury to one an injury to all.

Instead of the conservative motto, "A fair day's wage for a fair day's work," we must inscribe on our banner the revolutionary watchword, "Abolition of the wage system."

It is the historic mission of the working class to do away with capitalism. The army of production must be organised, not only for everyday struggle with capitalists, but also to carry on production when capitalism shall have been overthrown. By organising industrially we are forming the structure of the new society within the shell of the old.
